## Estimadx Latinx Law Student:

On Thursday, May 4, 2017, the East Bay La Raza Lawyers Association ("EBLRLA") will hold its biannual scholarship and judicial excellence awards dinner. We will present our Judicial Excellence award to the Honorable Delia Trevino, Judge of the Alameda County Superior Court. Her appointment makes Judge Trevino one of only two Latinas who sit on the Alameda County bench. We will also present La Luchadora award to Roseann Torres-Caraves, a long time EBLRLA member and past Board Member, and current Oakland Unified School District School Board Member.

Additionally, EBLRLA has created a new award – the Tag Team Luchadores – to honor a group of people. The inaugural awardee is Centro Legal de la Raza's Immigrant's Rights Program. The evening's Keynote Address will be delivered by Maria Blanco, Executive Director of the Undocumented Legal Services Center, which operates out of UC Davis School of Law to provide immigration-related legal services for undocumented students at the six University of California campuses without law schools.

The scholarship(s) funded by the dinner is for law students who (1) self-identify as Latinx; (2) live, work, or study in the East Bay (Alameda and Contra Costa counties); (3) have demonstrated their commitment to using the law to advance social justice; and (4) who can attend the award ceremony. The scholarship is open to 1L, 2L, and 3L students. The scholarship amount is contingent upon the amount of money raised. In the past, we have awarded scholarships in the amount of \$2,500. EBLRLA has also decided to earmark one scholarship for a student who has or will engage in deportation defense work.
