Dear Ms. Graham:

This is the **fourth rolling release** in response to the above Civil Action and Freedom of Information Act request for records from the BOP regarding the technical features of the inmate email system. Your request contains nine (9) different items.

Processing of a FOIA request includes the identification and removal of nonresponsive pages and pages generated by the email search indicating specific attachments from responsive records. This step is time-consuming and detailoriented process involving a page-by-page review of records retrieved as a result of a search for records. This step in the processing of responsive records does not result in any pages being generated for release.

This fourth rolling release includes the processing of a total of 859 pages. After careful review, we determined that 802 pages were identified as non-responsive and removed from the responsive records. These pages are non-responsive to your request because the records do not relate to any of the nine items listed in your original request. Additionally, 16 pages were identified as pages generated by the search process and removed from the responsive records. These pages are non-responsive must be a page that notes the specific attachments. These attachments are noted on the email thread which produces this page.

After removal of non-responsive pages and the system generated additional pages, this resulted in a total of 41 pages responsive to items 1 through 9 of your request. Of these pages, 2 pages are appropriate for release in full, 19 pages are released in part, and 20 pages are duplicate pages of pages 13-15 and 16-18 from this release and pages 202-209 in the 2nd rolling release and not included in the

released documents for this release. Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, records were redacted and withheld in full under exemptions (b)(5); (b)(6); and (b)(7)(C).

Records previously forwarded to the Executive Office for United States Attorney's (EOUSA) for consultation are included in this release. A total of 8 pages of records were reviewed. Of these pages, 2 pages are appropriate for release in full and 6 pages are released in part. Pursuant to the FOIA, 5 U.S.C. § 552, EOUSA redactions are withheld under exemptions (b)(5) and (b)(6) and BOP redactions are withheld under exemptions (b)(6) and (b)(7)(C).

Records maintained by the Executive Office for United States Attorneys (EOUSA) were referred to the BOP by FOIA request number 2018-005641 and included in this release. A total of 71 pages of records which originated with the BOP were forwarded and reviewed. Of these pages, 54 pages are appropriate for release in full and 9 pages are duplicates of pages 44-52 from this release. The remaining 8 pages from this referral will be processed with the next rolling release. Pursuant to the Freedom of Information Act, 5 U.S.C. § 552, redactions are withheld under exemptions (b)(6) and (b)(7)(C).

5 U.S.C. § 552(b)(5) concerns certain inter- and intra-agency communications protected by the deliberative process privilege, the attorney work-product privilege, and/or the attorney-client privilege.

5 U.S.C. § **552(b)(6)** concerns material the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties.

5 U.S.C. § **552(b)(7)(C)** concerns records or information compiled for law enforcement purposes the release of which could reasonably be expected to constitute an unwarranted invasion of the personal privacy of third parties.
