They seek nine categories of records related to Defendant U.S. Immigration and 19 Customs Enforcement's ("ICE") use of BI, Incorporated's SmartLINK App as part of its 20 Intensive Supervision and Appearance Program ("ISAP"). Plaintiffs filed this lawsuit against 21 ICE and the U.S. Department of Homeland Security (collectively, "Defendants") on April 14, 22 2022. ECF No. 1. Defendants filed an Answer on May 23, 2022. ECF No. 10. 23 **Status of Litigation** 24 Since the updates presented in the parties' Sixth Joint Status Report, ECF No. 36, the 25 parties have continued negotiating about the scope of future summary judgment briefing. The 26 parties are still working together to try to narrow any disputed issues, particularly regarding the 27 searches that were conducted, as well as to identify a proposed briefing schedule. 28
